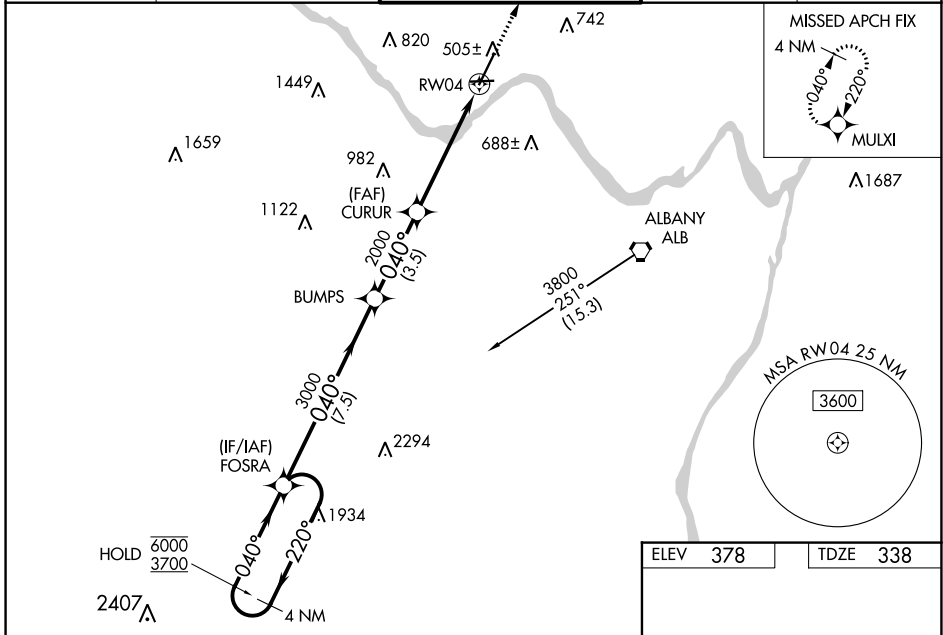

For inop ALS, increase LNAV/VNAV all Cats visibility to 3/8 SM and LNAV Cats A/B to 1 SM and Cats C/D to 1 1/8 SM. For inop ALS when using Albany altimeter setting, increase LPV all Cats visibility to 3/8 SM, increase LNAV/VNAV all Cats to 3/8 SM, increase LNAV Cats A/B visibility to 1 SM, and Cats C/D to 1 1/8 SM.
