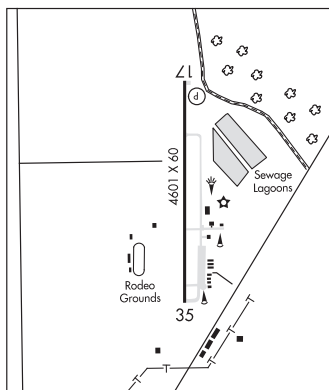

Rwy 02-20 has a fair sfd cond, it is very shrt (1400 ft) and the last 200 ft (Rwy end 02) has a dog-leg twd the river. Rwy 02-20 thr edges mkd with W rock bndry mkr.
